The Board of Mabion S.A. \_ "the Company" \_ hereby informs that on 8<sup>th</sup> June 2018 the Management Board of the Warsaw Stock Exchange \_" GPW" \_ passed a resolution on admission and introduction of P class ordinary bearer shares to stock exchange trading on GPW Main Market.

Pursuant to the adopted resolution, 1.405.999 P class ordinary bearer shares of the Company of nominal value 0,10 PLN each are admitted to stock exchange on the Main Market.
